Management Team & Structure

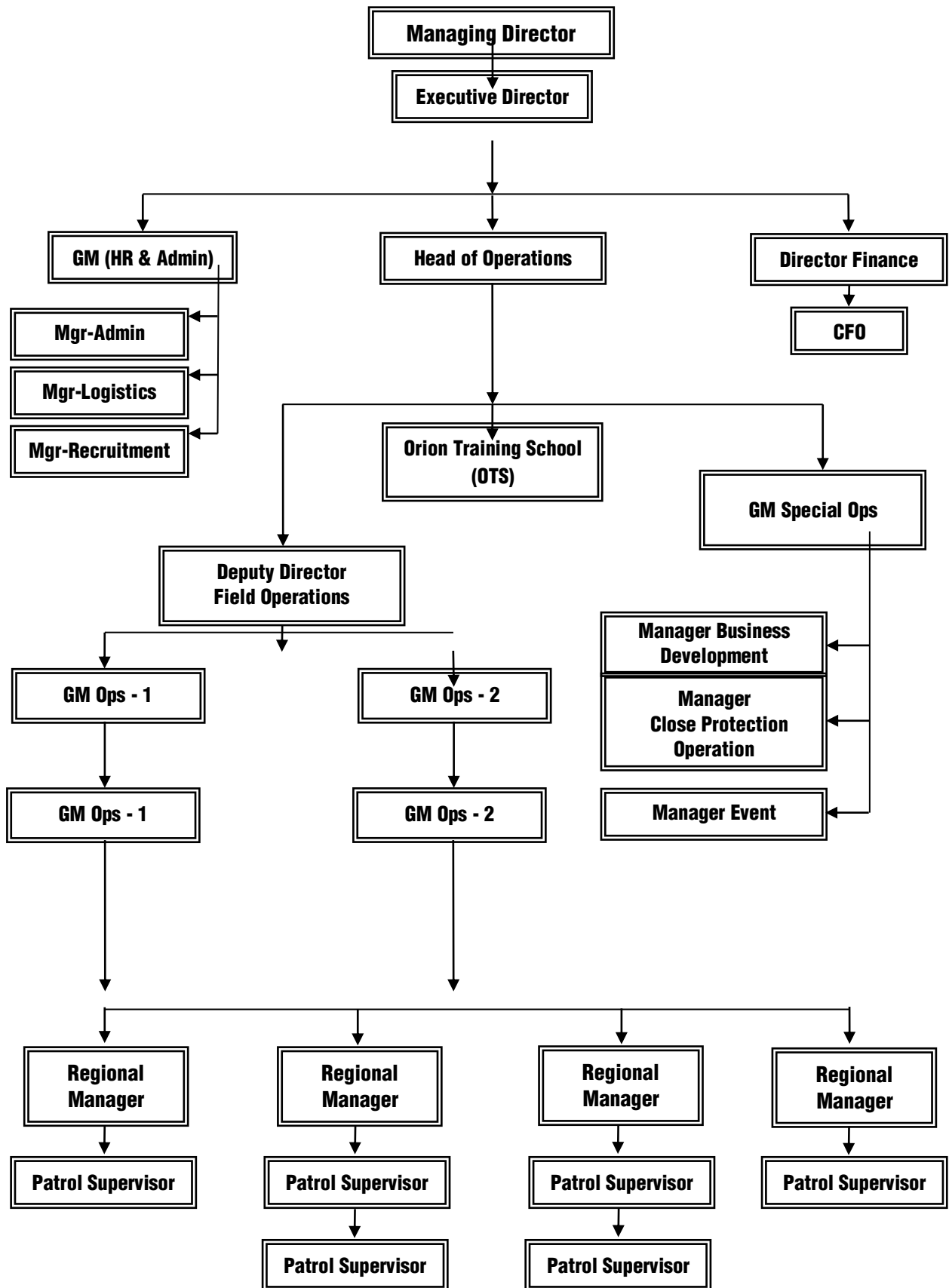

RECRUITMENT, SELECTION & VERIFICATIONS

Recruitment and Selection

For employment in Orion all candidates must go through a set of selection process to find those individual, who exhibit essential qualities to becoming a security guard, i.e; physical fitness, educational qualifications, truthfulness, courage, integrity, reliability, commitment & sound judgment. Our recruitment process includes various progressive steps. We have a dedicated recruitment team for carrying out recruitment. Orion conducts written test for the selection. The attributes we look for are:

- Whether individual is capable of writing and reading a script
- Whether his knowledge and written abilities match his qualifications
- Whether he is able to keep written records of visitors / goods while performing duties at a post
- Whether he has basic security knowledge

Background Checks/Verifications

Genuineness of security personnel's background and antecedents are given due importance by Orion. To ensure that we do not hire a wrong person we follow a set procedure. These include:

- National ID.
- Chairman Certificate in original
- Education Certificate
- Passport size photographs
- Retain finger impression.
- Record temporary & permanent residential address
- Reference from at least two referees.
- Initiating verifications roll to the Special Branch of Police.

In special cases if security personnel is required to be placed in high security zone, our own Investigation Officers carryout background check of the individuals.

- Height : Minimum 5' 5" for Male and 5.2" for Female
- Communication Skill: Fair in English Spoken and Writing

- Physically FIT - Declared by Orion Medical Officer
- Experience : Retired Armed Forces, Police and Ansar Personnel preferred.
- Must have at least two References

TRAINING OF GUARDS

Orion Security Training Center

Orion strongly believes in training. Without proper training a guard cannot perform better and grow in confidence. Before deployment, we organize two to three weeks intensive basic training for guards in our training school at 720/1, Shanti Niketon road, Maderbari, Uttarkhan, Dhaka. Training of guards at the training center is being conducted by qualified instructors. Most of the instructors are from defense services and police back ground. Training is our full time commitment. We have complete in house training infrastructure for our guards. These include barracks, training shed, training grounds, qualified instructors and training aids. This is an independent training establishment being run under direct supervision of the senior operational management team. We believe that training is a continuous process. Keeping the need of the clients in mind we conduct training in following steps to ensure that a guard is sufficiently equipped/trained to perform duties at any given security post:

- Basic Training for two to three weeks in Orion Training Center
- Practical/Orientation Training at the post
- Refreshers training once in six months
- Pre-deployment training for one week before deployment in high profile clients post.
- Post orientation training by field supervisor whenever/wherever possible.



Training Methods/Syllabus and Duration

Orion focuses on security personnel's both physical and professional abilities to perform his/her duties in all prevailing situations. Thus both intensive physical and professional training curriculums are being carried out for a duration of 07 days with best possible efforts to meet the client requirements. More emphasis is put on practical training method. About 70 percent classes are allotted for demonstration and practical classes. We always welcome our both existing and potential clients to visit the training center to physically review the details of our training syllabus (Block & Detailed Syllabus, Check Sheet, and Weekly Training Program) along with the existing facilities and arrangements.

This facility is basically used for pre-deployment traing of selected guards in a specialized or high value post. Training is generally conducted by senior operations manager of the company. We also invite clients representative to speak before the trainees and share his experience and expectations.

Orion carries out refreshers training of security guards performing duties in clients premise. Refreshers training is conducted every after six months. We conduct this training in our training center or clients premise. In such training in mist cases clients representative remains present and delivers his lecture, share his experiences and advice guards to improve their performances farther.

24x7 CONTROL ROOM OPERATIONS

Orion maintains effective and continuous communication with clients at all levels. Any deviations in the field are instantly detected due to continuous monitoring. As a result of early detection it becomes easier to offer timely and appropriate solution to the security problems in the field. For ensuring that all complaints are received and addressed in time, we maintain a 24/7 Control Room at our Head Office with a duty officer working round the clock. All incidents reported are recorded in the Duty Officer's LOG register and placed before the senior operational management for decision if the problem is of complex nature. For maintaining effective communication network, we use modern communication gadgets/facilities, i.e, telephone, mobile phone, facsimile, internet, e-mail, Wi-Fi services and computer networking (in house).



Field Supervision Mechanism / Procedures

A planned, well-coordinated and systematic supervision is essential to ensure optimum performance of guards. Supervision is further more important because Orion operation is spread all over the country reaching up to the remotest corners. For effective supervision Orion's operational area has been divided into various sectors/areas/zones. Supervisors have been allotted with mechanized transports, i.e; motorcycles/microbus to cover total operational area. We carry out supervision of guards through combination of the followings:

- Supervision by the designated Post Supervisions.
- Supervision by Regional Supervisors.
- Supervision by officers from Head Office.
- Surprise checking.
- Monitoring over mobile phone from 24x7 Control Room.
- Night Checker

Short Term Deployment in Emergency

The number of security personnel for short term deployment is not fixed or limited. As Orion maintains a full time training school, 20 to 25 security personnel always rolls over for basic and refresher trainings, which all can be deployed at any time and place in times of crisis. Besides, Orion has committed reserves (deployed in posts), who remains on call for any deployment on emergency requirements.

Labor Law

- Leave (casual leave, GOB holidays. medical leave, earn leave etc). Issuance of Appointment Letters, ID Card, Uniform. Issuance of PPE (FT Boot. Steel Helmet, Baton, Eye Protecting Glasses etc)
- Insurance for natural and accidental death. Provident Fund, Gratuity, Festival Bonus (when applicable)

Human Rights

- No gender biasness, equal opportunities for both men and women.
- No religion, race, caste or ethnic discrimination.
- No discrimination for indigenous people or people from hill districts or reserve forests.
- No specialized preferences for people from a particular district or region.
- Any Bangladeshi national above 18 years of age despite his/her ethnicity is eligible for employment in ORION provided he/she fulfills certain criterion required for the particular vacancy.

Labor Standards

- Forced Labor (security deposit, original National ID, original education certificate, passport etc) is forbidden.
- No Child Labor (Birth certificate, National ID, HR Manual, Personal File).
- No discrimination for salaries for same nature of duties, seniority/appointment, designations, rank structure.
- Employment Conditions (Room space, washing room facilities, dining facilities, fan, lighting facilities etc) are ensured.

Health & Hygiene

- ORION has a Medical Officer who carries out health & hygiene inspections on periodical basis of head office, training center and accommodations.
- We are training one Medical Assistant who will carry out health and hygiene inspections of guards living accommodations.

- Training curriculum of guards contain classes on health, hygiene and sanitation.
- Every month our cooks undergo medical examination by Medical Officer before declaring him/her FIT for cooking. Cooks are issued with cooking aprons, caps, hand washing soaps, towel etc.
- We encourage our employees to drink purified/boiled water while in the office/training center or duty post. We have water dispenser in our office as well.

Safety Measures

- Classes on fire-fighting and other safety measures are included in basic guard training syllabus. This also include wearing PPE while performing duties in hazardous areas and during movement from one place to another by motorcycle, vehicle or on foot
- Fire and Evacuation Drill is carried out in the head office on regular interval. Events are recorded in the fire drill register
- Fire extinguishers have been fixed on both the office floors (Ground & 1st floor)
- A Fire Point with firefighting facilities/equipment has been erected in ORION training center
- One First Aid Box each is kept in head office, training center and patrol vehicle respectively
- We maintain accident/incident registers/records
